This Certificate of Registration is awarded to **Binda Children Home for Girls under Life Line Trust**, Shanthi Nagar, 1st Cross, Chinnathirupathi, **Salem District- 636 008** as an institution for children in need of care and protection vide **S.No.1369/DSD/2020** under section 41(1) of the Juvenile Justice (Care and Protection of Children) Act, 2015. **This certificate of registration is valid for five years from the date of issue and is subject to the following conditions:-**

1. The Management should run the institution in accordance with Juvenile Justice (Care and Protection of Children) Act, 2015.
2. Based on the infrastructure available at present, the institution shall **admit a maximum of 46 Children (Girls) only.**
3. This certificate should be displayed prominently for the information of parents / general public in the office room.
4. The following words may be mentioned in the name board of the Institution **Binda Children Home for Girls under Life Line Trust, Shanthi Nagar, 1st Cross, Chinnathirupathi, Salem District- 636 008 is registered by Commissioner of Social Defence under Juvenile Justice (Care and Protection of Children) Act, 2015 as Children's Home.**
5. The services to the children shall be provided by the institution as per section 53 of Juvenile Justice (Care and Protection of Children) Act, 2015.
6. The institution shall have a Management Committee in accordance with the Rules to manage the institution and monitor the progress of every child.
7. Institution should follow rules / regulations issued by State Government / Director/ Commissioner of Social Defence from time to time.
8. The Institution is subject to inspection by the inspection authorities under the Act / Rules and by the persons / officers authorized by the State Government / District Child Protection Society / Child Welfare Committee.

9. Orders should be obtained from Child Welfare Committees for all admissions and discharge.
10. Any admission / death / repatriation of the children in the institution and any discharge of children from the institution should be intimated to the concerned District Child Protection Officer and Child Welfare Committee in accordance with Tamil Nadu Juvenile Justice (Care and Protection of Children) Rules, 2017.
11.
 - i) Structural Soundness Certificate issued by a registered Engineer under sub-section 4 of section 4 of the Tamil Nadu Public Buildings Licensing Act, 1965 (Act XIII of 1965) – **valid up to 17.03.2021,**
 - ii) License issued by the competent authority under sub-section (1) of section 6 of the Tamil Nadu Public Buildings Licensing Act, 1965 (Act XIII of 1965) - **valid up to 17.03.2021,**
 - iii) No Objection Certificate from Fire Service Department – **valid up to 04.07.2020,**
 - iv) Sanitation Certificate issued under the Tamil Nadu Public Health Act, 1939 (Tamil Nadu Act III of 1939) – **valid up to 23.05.2020** should be renewed periodically before expiry date
12. The registration certificate is valid for the period mentioned therein and is subject to the condition that the certificates mentioned in 11 (i) to (iv) above are renewed in time before expiry and a copy has to be furnished to the District Child Protection Officer of Concerned District and to the Commissionerate of Social Defence.
13. The Institution shall ensure proper education, child rights and necessary safeguards from child abuses.
14. The Institution shall ensure water and sanitation and also safe drinking water.
15. The Institution shall arrange recreation and motivation activities.
16. Rain Water harvesting facilities should be made in the Institution.
17. The Institution should not have any Thatched structure.
18. Required number of firefighting equipment should be installed and personnel also should be trained in handling them.
19. This registration shall be deemed to be withdrawn in case of violation of any of the conditions by the institution.
20. Home management committee should be formed and conducted regularly as per rule 49 of Tamil Nadu Juvenile Justice (Care and Protection of Children) Rules, 2017.

The registration shall be subjected to the conditions laid down in the Juvenile Justice (Care and Protection of Children) Act, 2015 and the Rules made thereunder. The institution should comply with Rules / Regulations / Instructions issued by the State Government / Commissioner of Social Defence from time to time.

Salem District -637 101.


Therefore, the DCPO, Salem has inspected to Binda Children Home for Girls
under Life Line Trust and verified the infrastructure facilities provided to children as per
Tamilnadu Juvenile Justice (Care and Protection of Children) Rules, 2017 and based
on the inspection report she has recommended for modification in the accommodation
capacity of children and Change of address of the Institution. The Institution has also
furnished new Building Stability Certificate, Building License Certificate, Sanitary
Certificate, NOC from Fire & Rescue Department of the new building.

The District Child Protection Officer, Salem District has reported that following infrastructure facilities and Staff are structure available in the institution.

Hence, as per the present situation in the institution, a partial modification to the registration certificate issued vide Proc.No.3283/D2/2020, dated:11.05.2020 is issued herewith. as address of the Institution from Binda Children Home for Girls under Life Line Trust, Shanthi Nagar, 1st Cross, Chinnathirupathi, Salem District -636 008 to Binda Children Home for Girls under Life Line Trust, Aavaniperur Melmugam Village, Opp to Mariyamman Kovil, Chinnamuthur, Vellarivelli (P.O), Edappadi (T.K), Salem District -637 101 which will be the place of functioning of the institution henceforth and based on the infrastructure / No.of staff available at present in the institution as reported by the District Child Protection Officer and according to the Tamilnadu Juvenile Justice (Care and Protection of Children) Rules, 2017, the accommodation capacity of Binda Children Home for Girls under Life Line Trust, Aavaniperur Melmugam Village, Opp to Mariyamman Kovil, Chinnamuthur, Vellarivelli (P.O), Edappadi (T.K), Salem District -637 101 has been re-fixed to **56 Children (Girls) as maximum sanctioned strength**.
